Open Enrollment for 2018 Medicare Prescription Drug and Health Plans begins October 15th

The Centers for Medicare & Medicaid Services (CMS) is encouraging all Medicare beneficiaries to take advantage of the annual Open Enrollment period to make sure they have the best coverage available to meet their health care needs in 2018.

If you or someone you care about has Medicare, make sure you mark your calendars. Medicare Open Enrollment starts on October 15th and ends on December 7th. Use this opportunity to review your current Medicare choices and compare them to coverage that is available for next year to make sure you have the plan that is right for you. You may be able to save money, get better coverage or both. And make sure you take advantage of the benefits for all people with Medicare – like wellness visits, preventive care and lower prescription drug costs. Regional Housing Development is seeking qualified candidates for the position of Maintenance Mechanic. The Maintenance Mechanic reports directly to the Associate Director of Operations and is responsible for the maintenance and repair of the Menard County Housing Authority's buildings and grounds. Qualifications include graduation from an accredited high school or possession of GED, supplemented by vocational/technical school training in carpentry, electricity, plumbing, heating and air conditioning, and/or related, with journeyman level skill in one of the recognized building trades; and four years progressively responsible experience in building and grounds maintenance, building construction, or related experience or a combination of education, training, and experience equivalent to the above. Other special requirements include possession of a valid driver's license; ability to be covered under RHD's vehicle insurance policy and fidelity bond; and must be willing and able to provide emergency coverage after hours.
